Effective October 1, 2025, updated encounter codes for licensed practical nurses (LPNs), registered nurses (RNs), registered nurses with certified practice (RN(C)s), registered psychiatric nurses (RPNs), and registered psychiatric nurses with certified practice (RPN(C)s) will be implemented within primary care settings.

This update is designed to resolve inconsistent code use across sites, clarify application, improve workflow integration, enhance data feedback mechanisms, and align coding with the current nursing scope in primary care.

A new Encounter coding for LPN, RN, RN(C), RPN, RPN(C): Guidance document will also be released to support implementation. Documents will become available as of the effective date at <http://www.pcnbc.ca>.
